Jane Hasek, with the Harpers Ferry Area Heritage Society, gave an update on the progress of the Harpers Ferry Museum Project.

Corey Snitker, Allamakee County Emergency Management Coordinator, presented the final draft of the Hazard Mitigation Plan and Actions for Harpers Ferry.

Upon motion by Kaeppel, second by Diggins, the following Resolution was approved:

Resolution 492-Adopting Allamakee County, Iowa Multi-Jurisdiction (MJ-7) Multi-Hazard Mitigation Plan

Motion by Diggins, second by Barta to approve the 2023-2024 winter LP bid for approximately 3,500 gallons from AgVantage FS for \$1.25/gal.

Four bids were received: AgVantage FS (\$1.25/gal), Waukon Food Ranch (\$1.35/gal), Consolidated Energy Co. (\$1.39/gal), and Welch Feed & LP (\$1.39/gal).

Motion by Garin, second by Riha to approve River Run Pub & Grub Class C Liquor License (LC Commercial), with Outdoor Services. Roll Call Vote: Ayes: Kaeppel, Garin, Riha, Diggins, Barta. Nays: None. Motion carried.

Motion by Garin, second by Barta to approve a variance at 116 Cedar St, Lot #4. Roll Call Vote: Ayes: Riha, Garin, Kaeppel, Diggins, Barta. Nays: None. Motion was carried.

Motion by Diggins, second by Kaeppel to grant permission for Bill Thias, owner of Portside Bar & Supper Club, to fill in the vacant ally between Jefferson and Lansing Harpers Road. Roll Call Vote: Ayes: Garin, Riha, Kaeppel, Barta, Diggins. Nays: None. Motion carried.

Miscellaneous: Mayor Valley reviewed a list of Happenings at City Hall, which consisted of tasks outside of the day-to-day work. Mayor Valley asked the council for their opinion about how to proceed regarding 221 3rd Street. Other topics briefly touched on: potential grant for the future sidewalk improvement project, seal coat across from Spillway Supper Club, mobile home skirting, and animal welfare concerns at 138 N Rhomberg Ave, as well as concerns on the condition of the property and its structures.

Motion by Garin, second by Riha to adjourn the meeting. Roll Call Vote: Ayes: Barta, Riha, Garin, Diggins, Kaeppel. Nays: None. Motion carried.
