

**ORDINANCE NO. 333**

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF  
HARPERS FERRY, IOWA, 2019, BY AMENDING THE  
SEWER SERVICE CHARGES EFFECTIVE July 1, 2023

BE IT ordained by the City Council of the City of Harpers Ferry, Iowa:

Section 1. Section 99.01, subsection 1 of the code of Ordinances of the City of Harpers Ferry, Iowa, 2019, is repealed effective July 1, 2023, and the following adopted in lieu thereof;

1. A quarterly service fee of \$66.00 shall be charged for each individual dwelling, including apartments and condominium units, and each business and industrial premises which do not have a meter connection.
2. Commercial businesses connected by a meter will be charged a quarterly service fee of \$66.00 for the first 20,000 gallons of water used and \$3.30 for every 1000 gallons used over that amount.

Section 2. All Ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed effective July 1, 2023.

Section 3. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. This ordinance shall be in effect July 1, 2023, and after its final passage, approval and publication as provided by law.




