## HARPERS FERRY GOLF CART REGULATIONS

**OPERATION PERMITTED.** Golf Carts may be operated upon the streets and alleys of Harpers Ferry by person(s) possessing a valid driver's license and are at least 16 years of age.

**VIOLATIONS.** The operation of a Golf Cart in violation of the golf cart provisions may be charged either against the operator of the golf cart or against the registered owner of the cart. FIRST VIOLATION: \$300, SECOND VIOLATION: \$400, THIRD VIOLATION: \$500, plus surcharge and court costs, and the mayor shall revoke the registration of the golf cart. **NO WARNINGS** will be given!

**HOURS.** Golf carts may be operated on city streets only between sunrise and sunset. Regardless of lights on golf carts, this does **NOT** permit it to be driven after sunset.

**PROHIBITED STREETS.** Golf carts shall not be operated upon any city street which is a primary road extension through the City. However, golf carts may cross such a primary road extension. Golf carts cannot be operated along Rhomberg Avenue/Great River Road.

**EQUIPMENT.** Golf carts must be equipped with a slow-moving vehicle sign and a bicycle safety flag at all times during operation and shall be equipped with adequate brakes.

**TRAFFIC LAWS APPLICABLE.** While being operated on city streets, golf carts are deemed to be motor vehicles and are subject to all provisions relating to the operation of motor vehicles.

**LIABILITY INSURANCE.** No person shall operate a golf cart on city streets and alleys unless there is an owner's policy of liability insurance in effect for the golf cart.

**REGISTRATION.** All carts need to be registered with the City and display current registration stickers visible on both sides of the golf carts. These ID stickers are permanent stickers – **DO NOT REMOVE**. Registration is annual, with the registration year extending from May 15<sup>th</sup> to the following May 14<sup>th</sup>, at which time it will expire. There are no refunds or prorated registrations.

**RENEWAL.** After initial registration, renewal stickers will be issued upon payment of the renewal fee. After May 15<sup>th</sup>, a delinquent fee of \$10 will be added to the renewal registration fee. The renewal sticker is a colored small sticker with the current year that will be placed on the original cart registration sticker, similar to stickers that are issued when renewing vehicles.

**RESPECT PUBLIC PROPERTY.** Golf Carts are considered motor vehicles, they are not to be driven on sidewalks or through the grass. They should be parked on the street or in parking lots, same as a vehicle. In addition, **NO driving through or in the parks!**

**SOLD GOLF CART.** If a golf cart is sold, the registered golf cart owner shall inform the City Clerk and request cancellation of the registration of the sold golf cart. Any existing registration for a golf cart shall be deemed cancelled upon its sale. If the new owner intends to operate the golf on any City street or alley, they shall register the golf cart and pay the initial registration fee.
