

ORDINANCE NO. 337

AN ORDINANCE AMENDING THE CODE OF ORDINANCES
OF THE CITY OF HARPERS FERRY, IOWA, 2019, BY
AMENDING PROVISIONS PERTAINING TO THE OPERATION
OF GOLF CARTS ON CITY STREETS AND ALLEYS

Be it ordained by the Council of the City of Harpers Ferry, Iowa:

Section 1. Section 77.09 of the Code of Ordinances of the City of Harpers Ferry, Iowa, 2019, is hereby repealed and the following new subsection is adopted in lieu thereof:

VIOLATIONS. The operation of a golf cart in violation of any of the provisions of this chapter may be charged either against the operator of the golf cart or against the owner if the golf cart is operated with the consent of the owner. In the case of violations by the operator of a golf cart operating with the consent of the owner, the violation shall be charged against the owner only as a municipal infraction and the following civil penalties shall be applicable:

1. In the case of a first violation - \$300.00 fine plus surcharge and court costs
2. For a second violation within one calendar year - \$400.00 fine plus surcharge and court costs
3. In the event of a third violation within one calendar year - \$500.00 fine plus surcharge and court costs, and in addition, the Mayor shall revoke the registration of the golf cart and it shall not thereafter be registered in the City pursuant to this chapter.

Three violations committed by the registered owner within one calendar year shall also result in the revocation of any registration and prohibition of future registration, regardless of whether any of the violations were charged as municipal infractions.

Section 2. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 3. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.




